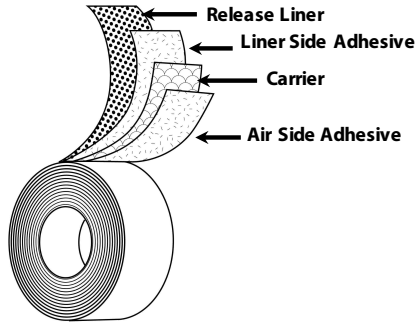


Double-Coated Foam Glazing Tape

- Backing/Carrier:** 1/32" 6lb Closed-Cell, Crosslinked White (or Black) PE Foam
- Air Side Adhesive:** Acrylic (I636)
- Specifications:** AAMA 810.1-16 for expanded cellular glazing tape
